- 2. GENERAL PUBLIC COMMENT** The public may provide comments to the Committee on nonagenda items within the Committee's subject matter jurisdiction. - 3. APPOINT COMMITTEE MEMBERS** In accordance with the ASNC Standing Rules, all standing committees must include a minimum of three and a maximum of 11 members. The members may include a co-chair and a secretary to take the minutes. Members remain on the committee until they resign, have two unexcused absences and/or a new Board is seated. Quorum shall be 50% plus one as required to hold a meeting. A simple majority of the quorum present may pass motions. Committees have no authority, except when specified by the Board, other than to make recommendations to the ASNC Board.
- 4. CLEANUP AT SYCAMORE GROVE BRIDGE** Councilmember Cedillo's office and Aztecs Rising have organized a cleanup this Saturday morning starting at Sycamore Grove Park bandshell and concentrating on the parkway overpass bridge and adjacent area along Griffin.
