Cody said now is a good time to ask for lights in dark public areas, the city has money for lights

Seconded the officers point to call and report things – make your voices heard so there is a record of complaints/calls when people advocate for you

He wants a list of abandoned building in the area, which are public safety hazards. They are going to make a push to complete half-finished buildings and/or deal with abandoned sites
